on the Government Action Plan for 2008–2009 related to the Decade of the Roma Inclusion Program Strategic Plan

Regarding Government measures for 2008 and 2009 necessary for the implementation of objectives as enshrined in Resolution 68/2007 (VI. 28.) OGY of the Parliament on the Decade of Roma Inclusion Program Strategic Plan (hereinafter referred to as Strategic Plan), in accordance with the Roma Integration Council, the Government hereby adopts the following Decision:

I. Tasks in the field of education

1. In the framework of the Sure Start Program, at least five programs have to be launched for the support of children under school age and, especially, of 0 to 5 years of age and their families living in the most disadvantaged micro regions and municipalities in order to break the deprivation cycle and to realize the early development of their skills. With a view to the results of the programs, their nationwide dissemination has to be provided for.

2. Extracurricular prevention and integration programs have to be launched in order to reduce drop-out from school and to create the conditions for a successful start of living for at least five hundred Roma and disadvantaged children of school age and young people.

3. Free catering should be provided for children receiving regular child protection allowance in upper forms of primary school education.

4. In the framework of the support of the implementation of one hundred and seventy equal opportunity action plans in public education, chance creating programs (especially those for desegregation, kindergarten education, integration and methodology, the revision of deficiency and the support of further education) affecting almost five hundred public education institutions have to be launched.

5. In order to create a high quality inclusive school model and to establish the professional cooperation of schools applying modern pedagogical methods, a program should be launched for the support of the conversion of at least thirty-five schools engaged in integration practices into methodological and hospitation service centers.

6. A program should be launched for the development of the foreign language proficiency and the support of passing language examinations of one thousand and three hundred Roma and multiplied disadvantaged students studying in secondary schools in every year.

7. A course should be operated aiming at the preparation of one thousand and three hundred Roma and multiplied disadvantaged students for standard or high-level maturity exam in every year.

8. For the maintenance and strengthening of the educational success of the Roma young studying in higher education and for the support of the high level mastering of their chosen field of expertise, four so-called “Invisible Colleges” have to be operated.

10. In order to handle drop-out from secondary school, at least eight projects should be implemented during the realization of the Second Chance Grammar Schools Program in which the needs of mothers with infants should be taken into account as a priority.

12. Scholarships and talent support programs promoting educational success for Roma and disadvantaged as well as multiplied disadvantaged students should be harmonized.

13. Professional conditions of teaching the Romani and the Beas languages in public education institutions should be created and developed. The development of material necessary for teaching of Romani and the Beas languages as well as related researches and surveys should be supported. Professional tasks related to Romani and Beas language teacher's and interpreter's training should be coordinated and supported and means by which the accreditation of such trainings could be promoted should be examined.

14. In order to create an environmentally conscious way of thinking and living of children being of kindergarten and school age living in the most disadvantaged micro regions, the network of forest kindergartens and schools should be expanded.

15. An IT training and development program should be launched for Roma Minority Self-governments.

II. Tasks in the field of employment and development of enterprises

1. In employment policy guidelines, tasks and actions aiming at the improvement of employment situation of Roma people should be mainstreamed. The guidelines involve the scheduling of the implementation of the tasks and the names of bodies responsible for implementation.

2. For the support of the entry into the labour market of Roma and disadvantaged employees, the obtaining of a marketable professional qualification as well as their being permanently present in the open labour market, the following should be launched:

- decentralized employment programs involving nineteen thousand persons,
- labour market programs supported by the Labour Market Fund,
- alternative labour market programs involving three thousand and two hundred persons, furthermore programs should be launched for the promotion of the employability of those living in estates and in estate-like habitations.

3. Public works programs linked to professional and professional-like training should be launched for the reintegration into the primary labour market of the disadvantaged permanently unemployed persons

4. In order to promote access to central programs ensuring benefit bonuses for people living in the most disadvantaged micro regions and municipalities, mostly Roma (START Plus and START Extra), and to those promoting the obtaining of a vocational qualification adjusted to market needs (Make a step forward! program) and to programs ensuring the development of competences and skills necessary for work, at least ten more persons should be employed in the Roma employment management network.

Trainings combined with employment (ensuring a maturity exam and a vocational qualification accredited under an OKJ number) should be launched for the employment in public education and public culture institutions of at least three hundred and eighty Roma employees. In the field of healthcare, social, child welfare and child protection services as well as with law enforcement bodies, the conditions for the launch of the program should be ensured.

6. A system of means promoting the labour market mobility (interregional employment processes) of disadvantaged employees living in disadvantaged micro regions and municipalities should be elaborated.

7. The reinforcement and development of at least seventy Roma micro-, small and medium enterprises should be supported by involving five more persons in the network of enterprise development contact points consisting of Roma experts and by tenders. The training of at least five hundred employees should be ensured in micro- and small enterprises without administrative capacity.

8. Complex investments creating job opportunities and complex technological investments of small and medium sized enterprises to be established and operating in disadvantaged micro regions, with a growth potential, should be supported by tenders.

9. During the planning and implementation of employment and enterprise development programs, involving institutions providing daytime care for children and alternative services, the participation of mothers with infants in these programs should be promoted.

III. Tasks in the field of housing and regional development

1. According to the experiences of the authorization practice of the building authorities, building legislation should be revised so that no new building permits be able to be issued in areas threatened by groundwater, flood or other environmental-health dangers.

The regulation and practice of implementation procedures applied against those arbitrarily moving into flats and services provided by the social benefit system and the child protection institution system should be revised so that the principle in the Act on the protection of children (according to which children may not be separated from their families due to financial reasons only) be enforced.

In the framework of the “No one left behind!” flagship program, complex regional development project targeting the most disadvantaged micro regions and municipalities (in education, culture, employment, social affairs and health care) should be launched, with a special regard to the reduction of segregation in public education and housing.

4. A program should be launched for the rehabilitation of the flats and living environment of segregated urban habitations and quarters left without infrastructure and for the promotion of the employment and social integration of those living there.

5. In order to have environmental injuries reduced in settlements and settlement-like environment, pilot programs promoting a more sustainable way of life and consumption opportunities supporting their dissemination should be launched.

6. A timetable should be elaborated in order to eliminate segregation in municipalities (Roma settlements) and in the regions. During the scheduling of programs aiming at the elimination of Roma settlements, those in areas threatened by flood or groundwater have especially to be taken into consideration.

Within the framework of the New Hungary Rural Development Program, in rural parts of the country, during the elaboration of Local Rural Development Strategies to be prepared by local action groups previously recognized, a consultation opportunity should be provided for the National Roma Self-government and to local Roma minority self-governments.

8. The opportunity of creating model (Roma) agricultural cooperatives in three regions (Northern Hungary, Northern Great Plain and Southern Great Plain) should be considered.

IV. Tasks in the field of health

1. By involving at least twenty municipalities in one of the most disadvantaged micro regions and at least two thousand disadvantaged persons, programs should be launched for the promotion of the participation at public health examinations (breast cancer and cervix cancer), the use of mobile

examination stations, with a special regard to those living in a segregated settlement.

2. By involving at least twenty municipalities in one of the most disadvantaged micro regions and at least two thousand disadvantaged persons, programs should be launched for the improvement of living quality and of health during which special attention should be paid to those living in the most disadvantaged settlements or a segregated settlements.

3. The preparation and the implementation of plans for micro regional municipality healthcare should be supported, with a special regard to most disadvantaged micro regions and municipalities. These programs should reach at least forty percent of the population living in disadvantaged and the most disadvantaged micro regions.

4. In order to develop the lifestyle and health saving competences of those living in municipalities, the most disadvantaged micro regions and in segregated

settlements, programs should be launched by involving at least ten civil organizations representing disadvantaged groups.

For the complex survey of the development of children of 0 to 7 years of age, state surveying data sheets, procedural and care protocols, including publications for parents of children with linguistic and comprehension problems, should be developed in order to promote early recognition and access to assistance services.

6. In the field of health care, employment incentive programs should be launched supporting the employment of Roma in professions where human resources are scarce. The proportion of Roma should reach 3 to 5% on average in such professions.

organizations), decision-makers and the employees of basic health care of at least twenty municipalities located in one of the most disadvantaged micro regions should be involved in the so-called sensitivisation trainings being part of the national communication campaign.

8. In order to promote equal access to healthcare services, the number of permanently vacant districts should be reduced by motivating and supporting programs in the field of basic health care (general practitioner's service).

In order to improve regional inequalities of specialized health care, that is (to realize specialized outpatient care centers being within 20 km and/or 25 minutes) specialized outpatient care should be supported in micro regions where specialized care financed by the state is presently missing and where the population of the micro region cannot be considered as cared for according to the quantity and the professional composition of eventual sparse publicly funded care.

V. Tasks relating to the promotion of mainstreaming of equal treatment and anti-discrimination

1. The Roma Antidiscrimination Customer Service Network should be developed by the professional training of lawyers contributing to the work of the Network and by adding fifty more premises to the customer service points.

2. By involving right protection civil activists (with a special regard to organizations representing Roma women) and Roma minority self-governments, an antidiscrimination alarming system for exploring cases violating the prohibition of discrimination should be established and / or further development of already existing initiatives should be supported, so that these be known by the Equal Treatment Authority in the greatest possible number. In the field of education, seven regional centers should be operated in order to explore and treat discrimination phenomena. For of Roma civil organizations and Roma minority self-governments, the support necessary for the above operation should be ensured.

3. The antidiscrimination activities of right protection, conflict settlement and crisis treatment offices established by Roma civil organizations should be supported.

VI. Tasks relating to culture, media and sports

1. By implementing eight programs, the regular sports opportunities of at least two thousand disadvantaged children and young persons should be supported, with a special regard to children receiving child protection care or living in children's homes.

2. By launching age group programs, and especially in the framework of Champion and Star Program of the National Junior Institute, minimum fifty talented Roma children and young people should be supported in their participation in top sports.

3. Programs and campaigns presenting the life of Roma people in an authentic way and those against discrimination as well as the training and employment of Roma program-makers and journalists should be promoted.

4. In order to present Roma culture in Hungary and in Europe in a proper way, the establishment and funding of a national Roma cultural centre operating under the responsibility of the state, appropriate for being a scene of arts and traditional groups, creative workshops, trainings, theatrical programs, concerts, festival programs, musical events, conferences, where a museum, a research centre and a professional workshop can be established has to be prepared.

5. In order to preserve Roma culture, Roma objects of artistic value in the institutional system of public culture should be digitalized and catalogued in cooperation with the National Roma Self-government.

VII Closing provisions

1. The Government hereby calls the Ministers affected to mainstream the horizontal policy aspects and support policy based on the principle of equal opportunities when implementing tasks foreseen in the fields of education, employment, housing, health care and culture and to prepare a guideline on equal opportunities and on anti-segregation.

2. The Government hereby calls the Ministers affected to submit a report on the actual situation of tasks laid down in the biannual action plan to the Roma Integration Council. Reports should also present the way Roma civil organizations and the National Roma Self-government were involved in the preparation and implementation of tasks laid down in the action plan and in the monitoring work performed along the indicators referred to in the Strategic Plan.

3. For Roma civil organizations and Roma minority self-governments of the most disadvantaged micro regions, tender counseling trainings and communication programs should be launched so that small and medium sized enterprises and civil organizations operating in the most disadvantaged micro regions be able to reach the tender announced in the frame of New Hungary Development Program in an efficient way.

4. Within the framework of the Roma Integration Council, the so-called Roma Steering and Monitoring Committee should be established, primarily with the cooperation of the civil representatives of the Council. As to the procedure, working plan and funding of the Committee, a proposal should be submitted.

5. In order to facilitate the fulfillment of the reporting requirement as laid down in point 2 of Resolution 68/2007 (VI. 28.) OGY of the Parliament on the Decade of the Roma Integration Program Strategic Plan, in accordance with indicators as referred to in the Strategic Plan and with the cooperation of the Roma Integration Council as well as the Roma Steering and Monitoring Committee operating under the auspices of the latter, a monitoring system should be elaborated.
